The packet includes a registration checklist, a 3-page registration form, a Parent/Guardian Declaration Form and a Verification of Residency Form. Please complete and submit along with the following:

- A copy of your child's certified birth certificate or passport
- A copy of your child's social security card or signed waiver
- Two proofs of residency for Pike County which must be a service provided to your home (power bill, propane, phone, sanitation service, water, cable/satellite, notarized lease, rental agreement)
- All bills must be current and show your street address as receiving service. If you own or lease
 your home, you must complete an Affidavit of Residence (Form A). If you
 live with someone else, and the bills are in their name, they must complete an
 Affidavit of Residence (Form B). You must also include a copy of their picture I.D.
 as well as two current proofs of residency
- A copy of parent/guardian driver's license, or other picture I.D.
- A copy of your child's Immunization Certificate (Form 3231)
- A copy of your child's Eye, Ear, and Dental Certificate (Form 3300)
- The person applying must be the parent or legal guardian.
- Custody papers (if applicable)

Application packet pick-up will be available starting March 7th, 2022, through March 25th, 2022, outside on the bench on the front porch of the Pre-K building, or online at www.pike.k12.ga.us. A completed application packet (registration forms and required documents) must be returned to the Pre-K Building, in the security lock box outside on the front porch of the Pre-K building. The building is located at 7454 U.S. Highway 19 South, Zebulon, GA 30295. All application packets must be returned to the lock box by 4:00 p.m. on March 25th, 2022, to be included in the lottery drawing.

Applications received after March 25th will be placed at the end of the waiting list, should a waiting list be needed. This will depend on the number of applicants and the number of Pre-K spaces. Once applications are processed, parents will be contacted with your child's lottery number. A corresponding number will be placed in the drawing. This number is only a tool to identify your child in the drawing and in no way indicates your child's position in the program. The drawing will determine each child's enrollment position, and each applicant will be notified by phone and/or mail. The number of available Pre-K spaces is contingent upon the final budget approved by the Georgia legislature. Currently, we have 88 spaces. The lottery drawing will be held April 13th at 10:00 a.m. at the Pike County Schools Auditorium

The 170-day Pre-K calendar for the 2022-2023 school year will begin August 9th, 2022. The number of days required by Pre-K is also contingent upon the final budget approved by the Georgia legislature. Calendars will be available as soon as possible.
